General Requirements for Dumpster/Container

1. Dumpster/Container shall be placed **only** at the location described above. If this location changes, a new application must be submitted. **Dumpster/Container may not be placed, even partially, in front of adjacent properties without the consent of the adjacent property owner.**
2. The Applicant/Permittee shall be responsible for any damage resulting from the placement or use of this dumpster/container.
3. Dumpster/Container must be placed a minimum of TWENTY (20) feet from any intersection.
4. Dumpster/Container must be placed a minimum of FOUR (4) feet from any driveway entrance.
5. Dumpster/Container must not be placed more than TWELVE (12) inches from the curb.
6. Dumpster/Container must not impede the flow of pedestrian or vehicular traffic and must not cause any site distance issue for vehicular traffic.
7. Dumpster/Container must have a minimum of EIGHTEEN (18) inches of reflective material or lights on **EACH OF THE EIGHT (8) UPPER CORNERS.**
8. Dumpster/Container must not prohibit or limit access to any fire hydrant or other necessary resource, facility, or infrastructure, as determined by the City.
9. Dumpster/Container must be placed in such a manner that it will remain stationary (i.e. wheels must not be able to move) for the duration of placement. Particular care must be exercised when dumpster/container is placed on an inclined surface. **ALL wheels must be chocked.**
10. Dumpster/Container shall be inspected by the City after placement. Any identified deficiencies must be corrected within TWENTY-FOUR (24) hours of notification to the Applicant/Permittee.
11. Once placement is approved, a Dumpster/Portable Storage Container Permit will be issued to the Applicant/Permittee in accordance with **City Code § 66-10**. For the duration of placement, this permit must be posted on the Dumpster/Container in a way that it is visible from the street. Applicant/Permittee is responsible for coordinating this with the Dumpster/Container Company.
12. Dumpsters must be emptied at regular intervals to ensure against litter problems or health hazards. Area around dumpster must be kept free of debris, trash, litter, construction materials, etc. Dumpster must not be overfilled, and contents of dumpster must not present a health or safety hazard or a nuisance, as determined by the City.
13. If a dumpster is removed (including to be emptied) and a different dumpster is set in its place, a new permit must be issued. This ensures that every dumpster meets the City's requirements.
14. **All Dumpster Permits expire THIRTY (30) days after the Date of Issuance. All Portable Storage Container Permits expire SEVEN (7) days after the Date of Issuance. After expiration, a new application must be completed and a new permit must be obtained.**
15. Only ONE (1) Dumpster/Container will be permitted at any given address/location at a time.
16. **Dumpsters may not be permitted for more than Sixty (60) days. After Sixty (60) days, the dumpster must be removed from the location for at least THIRTY (30) days before the City will consider granting another permit.**
