The Planning Commission meets to conduct a public hearing and to consider applications for Special Use Permits, Site Plans, Subdivisions, Rezoning, and Zoning Text Amendments, on the second Wednesday of each month at 6:30 p.m. in Council Chambers, City Hall, 715 Princess Anne Street, Fredericksburg, Virginia. A second meeting (if necessary) would be scheduled for the fourth Wednesday of the month at 6:30 p.m. in Council Chambers.

The applicant, or his or her representative, must be present to answer questions from the Planning Commission. Applicants must submit **complete applications, along with the application fee, payable to the City of Fredericksburg**, to the Community Planning and Building Department, 601 Caroline Street, Suite 400 – Executive Plaza. **Carefully follow the instructions listed on the application for submitting a complete application**. Office hours are Monday through Friday, 8:00 a.m. to 4:30 p.m.

Only complete applications will be forwarded to the Planning Commission for its consideration. Filing dates are established to allow sufficient time to process applications and comply with public notification requirements. Public notices will appear in the Fredericksburg Free Lance-Star.
