



# City of Fredericksburg Farmers Market 2023 Kids' Market Application

The City of Fredericksburg's Farmers Market is pleased to present its annual Kids' Market on Saturday, June 10, 2023 from 9am – 1pm at Hurkamp Park. This market is for children from 8-15yrs old to sell their homemade items, Saturday, in conjunction with the Fredericksburg Farmers Market.

**Children must be from the Fredericksburg/Spotsylvania/Stafford/King George areas.** Space is limited. Applications are selected on a first-come first-served basis, with the goal to offer the greatest variety possible.

### Kid's Market Guidelines:

- Participants will be provided an assigned table within Hurkamp Park for the event. Participants are encouraged to provide a tent, signs for pricing, and advertising of their offerings.
- All items for sale must be made or grown by the child and their immediate family. They may sell: handcrafted items (e.g.: jewelry, candles, soaps, tie-dye, and art), homemade food items packaged accordingly (e.g.: muffins, granola, lemonade, cookies, cake pops, cupcakes), plants, vegetables, herbs, and eggs are permitted.
- **NO resell of 'premade items' purchased from stores will be allowed.**
- Each table with a child selling must have an adult chaperone (18 and older) at all times. The adult is responsible for overseeing the set-up, transactions, and break-down of the child's table.
- **Check in with the Market Manager upon arrival.**

**Applications must be received by May 31<sup>st</sup> to be considered.**
